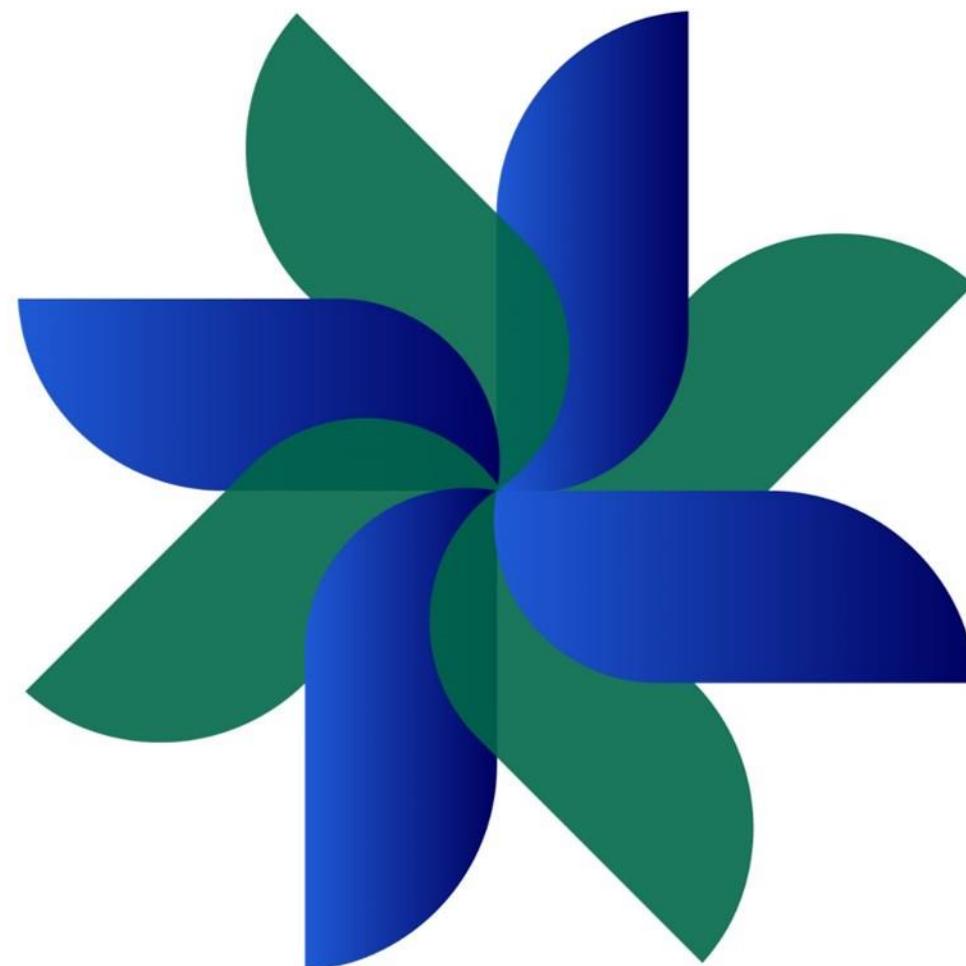

## 1. General Provisions

The System Fees shall be an integral part of the *Mir Payment System Regulations* (hereinafter referred to as the Regulations) and contain the amount and essential conditions of charging fees for the services rendered to Mir Participants (hereinafter referred to as the Participant).

The Fees shall not be applied to Participants as per type E activities.

The Mir Operator may unilaterally alter and amend the current Fees upon prior notification to the Participants in the manner and within the timeframe specified by Cl. 1.2 of the *Mir Payment System Regulations*. The Fees shall be expressed in the Russian Federation (RF) currency as a fixed amount or as a percentage of the transaction amount.

Fees for the Mir services shall be calculated in the Russian Federation currency. The Operator shall charge no joining fees.

In case of the service provision by the Operator (the payment for which is differentiated according to the period) during an incomplete month/quarter, the Operator's service fee shall not be subject to recalculation and shall be charged in the amount of the fee for the whole month/quarter.

The Mir Payment System Standard *Interchange Fees* is a document that regulates the interchange fee rates and the fee charging procedure for the Participants' Transactions. The Standard shall be communicated to the Participants by posting it on the System Information Resource and the Operator's official website: [www.nspk.ru](http://www.nspk.ru).

The Mir Payment System Standard *Interchange Fees* is applied in case when the Participants fail to notify the Operator of a new fee agreed pursuant to the procedure established by the Operator.

If the Participants notify the Operator of a new interchange fee agreed pursuant to the procedure established by the Operator, then this new fee rate shall be applied.

The Operator's notification procedure by the Participants is established in the Mir Payment System Standard *Individual Interchange Fee Rates Applied between Mir Participants*.

## 2. Operating, Authorization, Payment Clearing and Other Service Fees

### Fees

The Operator shall charge the Participant operating, authorization, payment clearing and other service fees. The fee amount is indicated herein net of taxes and duties established by the laws of the Russian Federation and the laws of the Participant's state of registration and/or the state where the Participant runs its business.

All taxes and duties imposed on a service shall be paid above the agreed fees.

Taxes and duties provided for by the laws of the Participant's state of registration and/or the state where the Participant runs its business shall be paid by the Participant independently, unless otherwise stipulated by the specified laws, including international treaties.

The services marked with Yes in the field *VAT in the Russian Federation* are subject to VAT in accordance with the laws of the Russian Federation or the Treaty on the Eurasian Economic Union (EEU). These services are subject to VAT in the Russian Federation.

The fee for the services marked with (\*) is not applied to Non-RF Participants until **March 31, 2024**.

The Participant's state of registration in the EEU is a state that is a member of the EEU.

### Frequency

Fees shall be charged with the frequency determined for each service.



**Procedure**

Operating, authorization, payment clearing and other service fees shall be included in the Participant's Net Position, unless otherwise specified in the Mir Payment System Regulations, Standards or herein. By acceding to the Regulations, the Participant entitles the Settlement Center to debit the Operator's fees included in the Net Position Register to the Participant's account.

Information on the services and service fees shall be included in the Participant's Payment Report generated by the Payment Clearing Center. The Report generation procedure and its format are specified in the *Mir OPCC Operational Procedure Manual. Part 2. Operational Interaction Guidelines*. The Operator sends to the Participant work completion/service provision certificates and invoices where provided for by the laws of the Russian Federation via the electronic document management system (NSPK SEDO). In addition, the Operator shall send hard copies to the Participant's address by mail or by special delivery, unless there is an exchange of documents signed using QDS. When sent via NSPK SEDO, e-documents are deemed received by the Participant in accordance with the SEDO rules.

The document exchange procedure between the Operator and the Participant is set forth in Section 12 of the Regulations.
